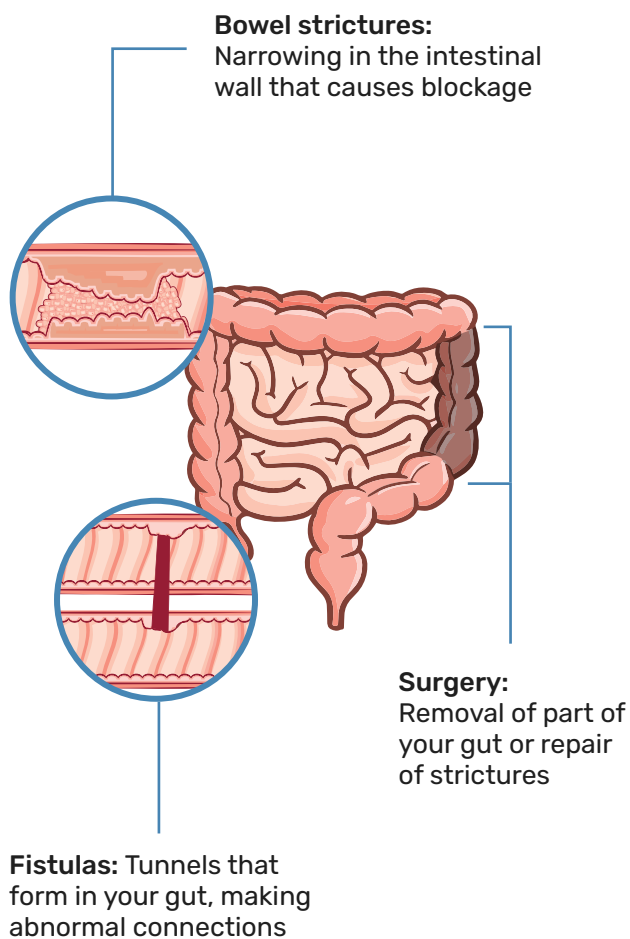
* CDPATH defines serious complications for patients with Crohn's disease as any fistulas or strictures in your bowels or any surgery in your bowels other than the area in or around the anus.

Crohn's disease can be unpredictable

Crohn's disease is chronic, unpredictable, and can often feel overwhelming. It's hard to know when symptoms will come and go and whether they'll be mild or severe. Underlying inflammation can cause your disease to worsen over time. The earlier you and your healthcare provider (HCP) can understand your risk for potential complications, the better you can partner to manage your care.

Potential complications associated with CD



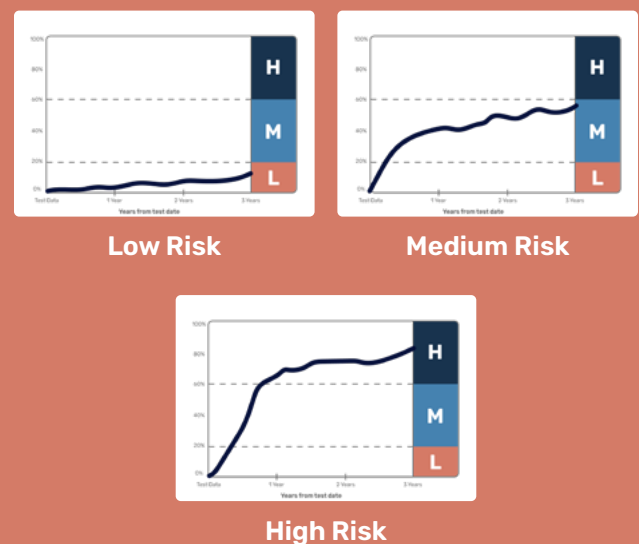
An innovative test to identify your unique potential risk

CDPATH combines an analysis of your blood's biomarkers and genetic information with your healthcare provider's (HCP) evaluation of your disease to determine whether you are at low, medium, or high risk for developing serious Crohn's disease-related complications within 3 years.

Graphical results for improved understanding

To help you understand your personalized risk profile, CDPATH results are presented in a clear and straightforward visual graph.* The information can help you and your HCP better understand your Crohn's disease and have more informed conversations about how to manage it more proactively.†

Sample reports showing the potential risk of complications over a 3-year period

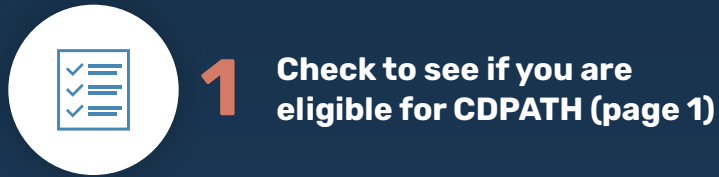


Actual charts will vary based on each individual patient's results.

* Your HCP will receive your results about 7 days after the blood is received by the lab for processing. Your HCP will set up time to discuss the results with you.

† CDPATH results are prognostic but not a conclusion or guarantee. You and your HCP should not rely solely on the risk predictions from CDPATH to make a clinical diagnosis or treatment decision.

How the CDPATH process works



1 Check to see if you are eligible for CDPATH (page 1)



2 Your healthcare provider (HCP) orders a CDPATH test kit and fills out the required paperwork



3 Determine where you will have your blood drawn
Visit "Where to Go" on [CDPATH.com](https://www.cdpath.com) if you need help finding a location



4 Take the kit and paperwork to your blood draw appointment
Your results will be sent to your HCP about 7 days after your blood sample is received by the testing laboratory



5 Go over the results with your HCP and discuss the path forward for proactive care
